## SPECIFICITY OF THE NATIONAL VALUES INTEGRATION IN THE PROCESS OF ENGLISH LANGUAGE EDUCATION

**Annotation:** professional training of young people in the world education system, selection of educational materials in pedagogical processes that guarantee educational results, in particular, issues such as the need to develop knowledge, skills, qualifications and competencies to improve the education of a future specialist based on the instillation of national values in the educational process and on the example of the Uzbek family on the basis of English language education are highlighted in the article.

**Key words:** professional training, English language education, uniqueness of the English language, movement, activity, spiritual heritage, national value.

**Introduction.** Creative mechanisms for improving pedagogical processes are being put into practice in educational institutions of developed countries in the world. According to the international normative document of UNESCO based on international qualification requirements, the use of innovative technologies in the educational process based on the development of pedagogical skills of teachers, the formation of "teacher - student - educational tool - educational environment", study of teaching and learning environment and working conditions of teachers according to TALIS - international assessment program, improvement of scientific research system, systematic works aimed at the implementation of large-scale projects on the formation of important scientific and professional qualities are being carried out.

Improving the activity of the teacher and student in the world educational and research institutions, case technologies, individual trajectory training, improvement of the credit system, planning the pedagogical process, scientific researches on the effective organization of the educational process are being carried out. At the moment, as a factor in the professional training of teachers in the world education system, remote implementation of lessons using the Internet and information and communication technologies, organization based on a specific project, focused on achieving a specific goal, which guarantees the result of education, selection and systematization of educational materials in pedagogical processes, special attention is paid to scientific research on the ensuring the activities of the teacher and the student in the learning environment.

Literature analysis. Therefore, scientific and innovative activities development, on the basis of specialized disciplines oriented to special goals, including the development of scientific and practical research on the basis of English language education, on the development of the creative competence of the future specialist based on the integration of national values and the need to develop relevant knowledge, skills, qualifications and competencies are an important problem of social pedagogy. It is one of the main factors of achieving the final goal in language teaching development of speech, linguistic, pragmatic competence through text analysis and on this basis to inculcate national values. The anthropocentric approach is notable for its great potential in inculcating national values [1].



Researcher M.Kholmatova also writes that, "in order to make the young generation confident in the future, it is necessary to deeply study the spiritual and moral heritage of our generation, to harmonize the direction of life with the purpose of the country, the people, and the state"[2].

The traditions and national values and experiences of the Uzbek people are interpreted in the work [3] of our great-grandfather Amir Temur's Laws", and in the works of the thinker Alisher Navoi [4].

Despite the fact that the content of the education system, priorities, and leading ideas on educating the young generation were defined in terms of the demands of the ruling ideology in our republic before independence, in the conditions of Uzbekistan, in addition to the natural sciences, the foundations of social and humanitarian sciences such as philosophy, art studies, and pedagogy were covered by examples of national cultural heritage, views representing national values and national lifestyle. For example, study of national values in sources created by N.Mallayev, H.Sulaymonov, F.Sulaymonova (Uzbek literature), E.Yusupov, M.Khairullayev, J.Tulenov (philosophy), M.Alaviya (art history), Z. Mirtursunov (pedagogy), attention is focused on introducing students to the ideas presented in them. With the honor of independence, there was an opportunity to study national values in a wide way in the educational process.

**Research methodology.** In the article, the preparation of professional youth in the world education system, selection of educational materials in pedagogical processes that guarantee educational results, in particular, national values based on English language education in the educational process and on the basis of integration in the example of an Uzbek family, issues such as the need to develop knowledge, skills, qualifications and competencies for improving the education of future specialists are discussed.

Decree number PF-5847 on October 8, 2019 "On approval of the concept of development of the higher education system of the Republic of Uzbekistan until 2030" defined the priorities for the systematic reform of higher education in the Republic of Uzbekistan. As a methodological basis for the development and future of our country and the subject of our direct research this decree directly and indirectly affects the spiritual and moral education of students.

**Analyzes and results.** The focus of the analysis is the development of national pedagogy in the period of independence, the use of national values and the heritage of ancestors to improve the spirituality of young people, taking into account the social need for their effective use in the preparation of future specialists, this topic is studied as a scientific and pedagogical problem awaiting its solution.

In the process of English language education, if our students learn this language well, we emphasize that the learner will discover a new technological world and will have a lot of interesting information in this world.

A very interesting fact has been revealed in English letters. The most common letter in the dictionary is "E" and the least common is "Q".

Those who are familiar with the English language in America are well aware that the same letters can be pronounced differently. Everything depends on intonation. One letter in a sentence can have several combinations of letters. There are many words in English that are distinguished by their pronunciation, spelling rules and sound. For example, the translation of the word "*rhythms*" means "*regular repeated patterns of sounds or movements*". This word does not have any vowel letter, but it is considered to be the longest such word of this kind in the English language.

*"Indivisibility"* is unity. Note that the vowel sound [i] occurs 7 times in this word. This word is one of the simplest words in the English language.

The next word is "set". This word, which seems small at first glance, has 7 different meanings for the verb. There are many variations of this word pronunciation. The diversity of this word makes translation difficult, so it is necessary to pay close attention to the pronunciation of the word and the meaning of the whole sentence. There in is also the longest word the English language, it is PNEUMONOULTRAMICROSCOPICSILICOVOLCANOCONIOSIS. It is hard to believe that this word is actually used in English. It is translated as a sentence meaning a disease and its name.

The historical heritage of the English language and the history of the emergence of the English language go back to Germany with its roots. In the Middle Ages, the tribes of Germany were once conquered by the Romans. During the invasion of British territory and communication a new incomprehensible language was created. Old English is different from modern English. For example: the translation of the word "*bride*" means "*a woman at the time she gets married or just after she is married*", and in the ancient language it meant the process of food preparation. Since that time, many words have been assimilated, not only words pronunciation and meaning, but also spelling rules have changed. It is also known that there were no punctuation marks in this language until the 15th century. Most of the lovers of the English language always emphasize direct theory, the fact that this language is very popular due to its simplicity and daily viability. However, this theory deserves to be rejected. This language has more than 800,000 words. Not only words, but also synonymous lines are rich with their own pronunciation. For example: the translation of the word "*drunk*" gives the meaning "*unable to control your behavior, speech because you have drunk too much alcohol*", this simple word has 2241 synonyms, which is a huge number. This record is even included in the Guinness Book of Records.

The English language is constantly being updated with new words. This means it is also very necessary to learn the language better.

Based on the evidence presented above, it can be said that this language will remain the crown of languages used by mankind for communication for many years (perhaps centuries). Learning it will be the main goal of all pupils, students and ordinary people who are ready to constantly develop.

We know that English is the language of modern society. Without knowing is impossible to communicate easily. In terms of special respectability, this language is widespread in every country, including Uzbekistan, so the opportunity to integrate national values increases from the large number of hours allocated to teaching English. From this point of view, studying the issues of integrating national values in the process of English language education is gaining urgent importance.

In the education system of Uzbekistan and in the Uzbek family, which is considered a sacred value, the upbringing of a generation faithful to the country, people, family, selfless, independently thinking, with a broad outlook and high faith, talented, enterprising, responsible, mentally and physically healthy, hardworking and diligent generation - guarantee of the development of our country, and, indeed, the significance and place of national values in national spirituality are incomparable.

In this place, it is emphasized in almost every English language lesson that the Uzbek people regard the family as sacred and treat it with deep respect. Because for everyone in this country, family peace and prosperity from time immemorial were considered great happiness. Nation's customs and traditions are the result of their educational efforts over many centuries. Through this system, our nation enriches its spiritual culture, virtue and psychology. "Always respecting our noble fathers and loving mothers, serving them, accepting their blessings, caring for our babies, our dear children and honoring them is a superior trait of our people, preserved over the centuries, which is the duty of each of us to be faithful to customs, to save and develop them"[5]. According to Muhammadjon Kuronov, to ensure a great future, it is necessary to have a great character [6].

Usually, professional activity is expressed in the legal documents of education, managerial skills, the administrative system, the introduction of information and communication technologies in the educational process and management, professional competence, knowledge of foreign languages, mainly English.

In the process of English education, we encourage students to always be active in learning the language. Action is a process subordinated to the idea of an achievable result, that is, a process subordinated to a conscious goal. The action is carried out on the basis of certain methods, in connection with a certain situation and conditions; they are called methods and represent a lower level in the activity structure [7].

Activity is one of the key components of effective English language learning. Indicators of pedagogical effectiveness are the activities of the teacher and student in learning the language and its final results. This idea was expressed by V.P.Simonova: "The effectiveness of educational activity is the level of achievement of the goals of activity by teachers, students, taking into account the acceptability (necessity and sufficiency) of their efforts, means and time."[8].

In the scientific works of the Honored Worker of Education, Doctor of Pedagogical Sciences, Professor Abdurashid Munavvarov, the duties and educational tasks of parents in raising children, the level of their culture and education, methods of raising children in Uzbek families, the coexistence of two or three generations, national traditions and values were expressed[9].

Indeed, the family is a special state within any state, such a social "organization"[10] in which social life and the continuity of generations are ensured, our traditions, sanctity of memory and, finally, ethnic culture are preserved, at the same time, it is developed, the experience passed from generation to generation is enriched with new traditions and national values, and it is passed on to future generations. That is why concepts such as "family education", "family culture", "family spirituality", "family behavior " (ethics) that are widely used in scientific literature having their own meaning, it is of great importance in describing the phenomenon of the family, which occupies a special place in the national-cultural values[11].

Decree No. PQ-3775 of the President of the Republic of Uzbekistan "On additional measures to improve the quality of education in higher education institutions and ensure their active participation in the large-scale reforms implemented in the country" became a historical document that raised educational work to a new level of quality in the higher education system of Uzbekistan. In this Decree "raising the process of training of highly qualified personnel with modern knowledge and high spiritual and moral qualities to a new level in terms of quality, modernization of higher education, development of the social sphere and economic sectors based on advanced educational technologies" was set as the goal. According to the decree, personnel with "high moral and ethical qualities, independent thinking" are being trained, and for this purpose advanced standards of higher education based on international experience are being introduced, including a phased transition from education aimed at obtaining theoretical knowledge to the education system, aimed at the formation of practical skills in educational programs; the need for the implementation of five initiatives was determined, including comprehensive measures aimed at creating additional conditions for the education of students and youth. The "Concept for the Development of the Higher Education System of the Republic of Uzbekistan until 2030" attached to the decree emphasizes that students have a lack of critical thinking skills, independent search and analysis of information, strengthening the spiritual and moral content of higher education, educating young people in the spirit of

patriotism based on respect to national values, humanism and high spiritual ideals, that it is necessary to further develop the work to strengthen immunity against alien ideas and ideologies.

As the researcher M.O.Inomova said, "National morality is formed as a result of national education. National value lies at the basis of national education" [12]. Also, in English lessons, working on texts about such qualities that are Uzbek national values as being an example, collecting the heritage of our ancestors, rare books related to ethics; visiting holy places, graves of deceased close relatives; information about the health of close relatives of the family; teaching children the right behavior at home through exercises, the right look i.e. teaching them a beautiful glance; active participation in wedding ceremonies held in the neighborhood; providing material and moral support to low-income people, those with many children, those who have lost their breadwinners, and those in need; tolerance towards representatives of other religions and nationalities, about friendship and the translation of such texts with this content if they are in Uzbek into English, the organization of questions and answers based on these texts is effective in instilling national values [13].

**Conclusions.** In the preparation and upbringing of all-round competent and morally mature specialists it is relevant to study national values, historical traditions, spiritual heritage, and experience of ancestors, in education, in particular, in the process of teaching English, it is important to apply the pedagogical ideas put forward in the content of education, based on the ideas of national values embedded in the content of texts recommended to students.
